The Washington Legal Foundation (WLF) will hold a media briefing ***Wednesday, June 27 at 8:30 a.m.*** at its M.J. Murdock Center for Free Enterprise, **2009 Massachusetts Avenue, N.W.**, Washington, D.C. (near the Dupont Circle Metro North Exit). The speakers will assess rulings that affect the free enterprise system and other key developments from the Court's 2006 term. Our panelists will be:

**The Honorable Dick Thornburgh**, who has served as Governor of Pennsylvania, Attorney General of the United States, and Under-Secretary-General of the United Nations during a public career which has spanned over 25 years. He is currently counsel to the Pittsburgh-based law firm of Kirkpatrick & Lockhart Preston Gates Ellis LLP in its Washington, D.C. office. He is the Chairman of Washington Legal Foundation's Legal Policy Advisory Board.

**F. William Brownell**, a partner in the Washington, D.C. office of the law firm Hunton & Williams LLP. Mr. Brownell's practice focuses on environmental litigation, regulation and counseling, including clean air regulation, environmental licensing and auditing, waste transportation and management, dangerous substances testing and labeling and water quality regulation. Mr. Brownell represents clients in both the United States and Europe.

**Roy T. Englert, Jr.**, a partner in the Washington, D.C. law firm Robbins, Russell, Englert, Orseck & Untereiner LLP, where he is an appellate litigator and antitrust lawyer. He served in the Office of the Solicitor General from 1986 to 1989 and more recently was a partner in the Washington office of Mayer, Brown & Platt. Immediately after law school, Mr. Englert was a law clerk on the United States Court of Appeals for the District of Columbia Circuit. He currently serves as an adjunct professor working with the Appellate Litigation Clinic of the Georgetown University Law Center. This term, he successfully represented the respondent in *Global Crossing v. Metrophones*, and filed numerous *amicus* briefs.

**Thomas C. Goldstein**, the head of the Supreme Court practice at the law firm Akin Gump Strauss Hauer & Feld LLP. In addition to practicing law, Mr. Goldstein teaches Supreme Court litigation at both Stanford Law School and Harvard Law School. Since 2003 he has been principally responsible for SCOTUSblog ([www.scotusblog.com](http://www.scotusblog.com)), which is devoted to coverage of the Court and is widely recognized as one of the nation's leading legal blogs. Mr. Goldstein argued on behalf of the respondent this term in *KSR v. Teleflex*.
